MARSHA: SINCE IT'S AT LEAST FIVE AFTER, I WILL GO AHEAD AND CALL US TO ORDER.

WE HAVE AS COMMITTEE MEMBERS -- DAVE, CARL, NAT NASH --

LAURIE: I'M SORRY. MARSHA, THIS IS LAURIE, COULD YOU SLOW THAT DOWN? I HAVE TO FINGER SPELL EVERYBODY.

MARSHA: I AM SORRY.

SO DAVE CARL?

DAVE: YEAH.

MARSHA: NAT NASH. AND THEN FOR OUR LOCAL PARTNERS, WE HAVE CARLEY. AND I KNOW HER LAST NAME STARTS WITH M, AND I AM BLANKING ON IT. ERIC THORNSTENSEN, AND LILLEY LONGSHORE. AND I THINK THAT IS EVERYBODY, PLUS RYAN AND LAURIE WHO IS INTERPRETING, AND EVELYN WHO IS TYPING THE TRANSCRIPT.

THE SQUARES KEEP JUMPING AROUND IN MY SCREEN, WHICH MAKES IT A BIT CHALLENGING TO CATCH UP.

OKAY. SO HOUSEKEEPING RULES,

RYAN: THIS IS RYAN SPEAKING. I WANT TO LET YOU KNOW THAT NATHAN, OUR MEMBER -- ONE MEMBER HAS BEEN EXCUSED, AND IS UNABLE TO MAKE IT ON TUESDAY, FROM 4:00 TO 5:00, AS A CONFLICT WITH THE PERSONAL APPOINTMENT, SO HE'S NOT HERE. AND EMILY IS NOT ABLE TO JOIN US TODAY. SHE IS IN ANOTHER MEETING AT THIS TIME FOR A FEW MORE TUESDAY, SO I WILL BE TAKING MINUTES. THAT'S WHY I'M USING THE TRANSCRIPT FOR LATER (INAUDIBLE) FOR EVERYONE; OKAY?

THANK YOU.

I KNOW THAT ZACHARY HAD SAID THAT HE WAS GOING TO BE HERE,

MARSHA: SO I'M NOT SURE WHAT HAPPENED WITH HIM.

RYAN: THIS IS RYAN. YES. YOU'RE RIGHT. ZACHARY SAID HE WAS -- HE DID SAY THAT HE WAS COMING. I'M NOT SURE WHAT'S HAPPENED, BUT IF HE'S NOT HERE, I WILL CHECK IN WITH HIM LATER ON.

MARSHA: OKAY. SOUNDS GOOD.

THE HOUSEKEEPING RULES, SPEAK SLOWLY FOR THE INTERPRETERS. I WILL TRY TO REMEMBER TO DO THAT. AND ANNOUNCE YOUR NAME BEFORE YOU SPEAK. ALTHOUGH, I GUESS IF I'VE CALLED ON YOU, THAT'S KIND OF REDUNDANT.

OKAY. I CAN'T BELIEVE IT'S ONLY BEEN A WEEK, SINCE OUR LAST MEETING. IT FEELS A LOT LONGER THAN THAT SOMEHOW.

AT OUR LAST MEETING, I'LL TRY TO DO A REAL QUICK UPDATE HERE. WE DISCOVERED THERE WAS A POTENTIAL MAJOR PROBLEM WITH THE LIBRARY IN THAT THEY DID NOT WANT TO RESERVE IT MORE THAN TWO MONTHS IN ADVANCE, WHICH WOULD MAKE GETTING THE NECESSARY GOVERNMENT CONTRACT DONE IN TIME. A SIGNIFICANT -- SO WE DECIDED TO -- I THINK, REALLY, THAT WAS THE -- PROBABLY THE BIGGEST THING.

I'M GLANCING AT THESE MINUTES, WHICH WE PROBABLY OUGHT TO APPROVE AT SOME POINT. IF SOMEBODY WAS WILLING TO MOVE APPROVAL OF THE MINUTES, ASSUMING YOU'VE HAD A CHANCE TO READ THEM.

MATT: MARSHA, THIS IS MATT. I MOVE THAT WE APPROVE THE MINUTES FROM THE PREVIOUS MEETING.

MARSHA: THANK YOU. IS THERE A SECOND?

DAVE: YES. THIS IS DAVE. I SECOND.

MARSHA: THANK YOU.

ALL IN FAVOR, PLEASE SAY AYE.

PARTICIPANTS: AYE.

MARSHA: ANY OPPOSED PLEASE SAY NAY, I GUESS.

OKAY. ANY ABSTENTIONS?

I'M GOING TO SAY THAT THEY'RE APPROVED.

SO WE GET TO START OFF THIS MEETING WITH SOME REALLY EXCITING NEWS. AND LILLEY AND CARLEY PUT IN YO-PERSON (PHONETIC) WORK AT THE END OF LAST WEEK TO MAKE THIS HAPPEN. I'M GOING TO ARBITRARILY AS IF CARLEY WOULD MAKE THE ANNOUNCEMENT, PLEASE.

CARLEY: WELL, I MET WITH MICHELLE, AND TO SAY THAT WE APPROVED THE -- OF THE ROOM, AND ALL THAT HOURS THAT WE WERE ALLOTTED. AND I BELIEVE THAT SHE SAID YES, BUT I HAD FAMILY COME INTO TOWN, SO I HAD REALLY APPROVE THAT. SO WHEN WHAT WE GET -- (INAUDIBLE).

LILLEY: YEAH. I WAS ABLE TO GIVE HER A CALL, AND ACTUALLY, YES. SO WE DO HAVE THE HEARING ROOM AT CLARK COUNTY BUILDING FOR THE 2ND -- THE 3RD OF NOVEMBER. 2ND OF NOVEMBER, WE CAN GO IN AT 2 P.M. TO SET UP. TENTATIVELY, SHE IS TRYING TO REARRANGE SOME THINGS TO ALLOW US TO START EARLIER THAN 6:30 P.M. BUT SHE SAID SHE WOULD CALL US THIS FRIDAY, SO ANOTHER DAY HERE, TO LET US KNOW FOR SURE IF WE CAN START EARLIER POTENTIALLY 5:30 OR 6 P.M. BUT FOR SURE 6:30, NO LATER THAN THAT. NOW, WE HAVE IT UNTIL 9 P.M. ON THURSDAY. AND THEN ON FRIDAY, WE HAVE IT FROM 7 A.M. UNTIL 11 A.M. SHE DID SAY -- THEY DON'T HAVE A LOT OF STREET PARKING AROUND THAT PUBLIC BUILDING, HOPEFULLY WE'LL HAVE A LOT OF PEOPLE USING THE BUS LINE, WHICH IS VERY CONVENIENT FOR THERE. IT IS STREET PARKING. SHE SAID THERE WON'T BE ANY PROBLEM AT ALL FINDING STREET PARKING ON THURSDAY, BUT ON FRIDAY MORNING, PEOPLE WILL BE AT WORK, BUT THERE WILL BE FEWER OF US, SO -- BUT IT'S STREET PARKING. THAT'S HOW IT IS.

MARSHA: ALL RIGHT. WELL -- AND LILLEY, I THINK I GAVE YOU THE WRONG NAME BEFORE. I APOLOGIZE FOR THAT.

LILLEY: WHAT NAME?

MARSHA: PARDON?

LILLEY: I DON'T KNOW. WHAT NAME?

MARSHA: I THINK I MIGHT HAVE SAID LAURIE.

LILLEY: OH, OKAY. I THOUGHT IT WAS A MIXTURE OF LILLEY AND CARLEY.

WE TOGETHER LARLEY.

MARSHA: YEAH.

LILLEY: SO I WAS ALSO GOING TO SAY, TOO, THAT I DID SPEAK WITH HER A LITTLE BIT. I DON'T KNOW WHAT THE OWL IS. THEY DO HAVE CAPABILITY IN THE ROOM TO MAKE IT THE TELEVISED WHATEVER IT IS. SO WHOEVER IS IN CHARGE OF SETTING UP THAT OWL, THEY SHOULD GIVE MICHELLE FINNING A CALL. I WILL -- MARSHA, I CAN SEND YOU HER NAME AND HER PHONE NUMBER AND WHATEVER -- SO THE PERSON CAN DIRECTLY CONTACT, BECAUSE I DON'T KNOW WHAT THE PIECES OF THE AUDIO VIDEO EQUIPMENT STUFF IS SPECIFIC, YOU KNOW, FOR WHOEVER IS SETTING IT UP, AND IT WOULD BE EASIER IF THAT WOULD BE A DIRECT COMMUNICATION INSTEAD OF THROUGH SOMEBODY IN CASE IT'S THE WRONG -- WE DON'T WANT TO GET SOMETHING WRONG.

MARSHA: IT WOULD BE SUPER-ANNOYING.

YEAH. PATTI DAILY --

RYAN: I'M SORRY. HOLD ON, THIS IS RYAN.

OKAY. JUST TO CLARIFY, THE TECHNOLOGY PIECE, YOU'RE TALKING ABOUT BETWEEN WHOM AND WHOM?

LILLEY: SOMEBODY MENTIONED SOMETHING CALLED AN OWL, AN O-W-L, THAT THIS COMMITTEE WANTS TO SET UP DURING THAT MEETING THAT WILL MAKE IT MORE ACCESSIBLE TO PEOPLE WHO ARE NOT THERE, AND I DON'T KNOW ANYTHING OTHER THAN THAT.

MARSHA: OKAY. THIS IS SO THAT WE CAN HAVE A HYBRID MEETING. WE CAN MAKE IT EQUALLY ACCESSIBLE TO PEOPLE WHO ARE NOT ABLE TO PHYSICALLY BE THERE, AS WELL AS TO THE PEOPLE WHO ARE THERE.

AND PATTI DAILY, WHO I HOPED WOULD BE HERE, IS NOT, IS THE ONE WHO HAS ACCESS TO THE OWL AT THIS POINT. SO I WILL -- IF YOU SEND ME THAT INFORMATION, I WILL GET IT TO HER AND ASK HER TO MAKE THAT CONTACT.

LILLEY: AND MAYBE THAT MICHELLE -- MAYBE WE HAVE AN ACCOUNT. THAT'S SOMETHING -- JUST SHARE THE LINK. SOMETHING IS IN PLACE. SO SHE MAY NOT EVEN NEED THAT. I DON'T KNOW ANYTHING ABOUT THAT STUFF. I'M JUST RELAYING THE INFORMATION AND THE POSSIBILITIES. I ALSO HAVE INFORMATION ON CATERING WHEN IT COMES TIME FOR THAT.

MARSHA: OKAY. THANKS. I THINK WHEN WE GET CLOSER, WE MAY WANT TO LOOP IN CLARENCE ESCRIDGE, WHO IS PROBABLY THE MOST TECH-MINDED PERSON ON THE GCD, AND I'M GUESSING THAT HE WOULD PROBABLY BE WILLING TO HELP US WITH THAT, IF POSSIBLE.

I'M JUST SEEING THAT IVY ANNE HAD STEPPED AWAY.

DID YOU HAVE CHANCE TO READ OVER THE MINUTES? DO YOU HAVE ANY CLUE WHAT WE'RE TALKING ABOUT?

IVY ANNE: I WAS IN MEETINGS ALL DAY. I'M ACTUALLY SKIMMING THEM RIGHT NOW, TRYING TO CATCH UP IN REAL TIME.

MARSHA: OKAY. ALL RIGHT. WELL, BASICALLY WE'VE BEEN SPENDING THE PAST COUPLE MONTHS TRYING TO FIGURE OUT EXACTLY WHERE WE WANTED TO FOCUS THIS MEETING. WE HAD STARTED WITH A POSSIBLE FOCUS ON RIDGEFIELD, WHICH IS A SUBURB, SOME DISTANCE NORTH OF VANCOUVER, AND FOR A WHOLE LOT OF REASONS DECIDED THAT THAT WASN'T THE BEST IDEA, AND WE REFOCUSED ON VANCOUVER ITSELF, BECAUSE OF TRANSPORTATION AND, YOU KNOW, A CONCENTRATION OF PEOPLE WITH DISABILITIES PROBABLY, IN THE CITY. LUCKILY, NOW WE HAVE A SITE. AND IT OCCURS TO ME, EITHER LILLEY OR CARLEY, THAT WE PROBABLY SHOULD GET THE ADDRESS OF THIS BUILDING SO THAT WE CAN INCLUDE THAT IN ANY COMMUNICATION.

CARLEY: THIS IS CARLEY. I WAS GOING TO SAY WE NEED AN ADDRESS AND THE ROOM NUMBER. I DON'T THINK WE SHOULD PRESENT IT, BUT YES. WE NEED TO START THINKING ABOUT HOW WE WANT TO DO A FLYER, SO WE WANT TO -- WE GET ALL OF THIS INFORMATION PUT TOGETHER, WE HAVE SOMETHING TO SEND OUT TO PEOPLE WHEN IT'S TIME.

MARSHA: YEAH. MY SENSE IS THAT THE STATE HAS ITS APPARATUS FOR SENDING OUT GCDE INFORMATION, AND BASED ON MY EXPERIENCE IN KITSAP COUNTY, THE COUNTY PROBABLY SO HAS A -- IT'S OWN CHANNELS FOR SENDING OUT INFORMATION, AND THEN, OF COURSE, INDIVIDUAL COMMUNITY MEMBERS PROBABLY HAVE THEIR OWN, YOU KNOW, WAYS TO LET PEOPLE KNOW ABOUT STUFF. SO I'M HOPING THAT WE CAN USE ALL OF THOSE.

I DON'T THINK WE'RE QUITE THERE YET, IF YOU'RE IN A MEETING AND PEOPLE ARE TALKING ABOUT DATES, IT WON'T HURT TO ANNOUNCE IT AND SAY THAT IT'S HAPPENING.

YES, CARLEY?

CARLEY: SO ARE WE TALKING ABOUT MULTIPLE -- MULTIPLE -- HOW DO I SAY THIS? MULTIPLE PIECES OF PAPER? SO ONE FLYER FOR EVERY COUNTY? I'M NOT SURE WHAT GD --

MARSHA: OKAY.

CARLEY: I DON'T KNOW WHAT YOU MEAN.

MARSHA: YEAH. I'M SORRY. I WILL -- I SHOULDN'T USE INITIALS. GCDE IS THE GOVERNOR'S COMMITTEE ON DISABILITY ISSUES AND EMPLOYMENT, AND THAT IS --

CARLEY: THANK YOU.

MARSHA: AND COMMUNITY OUTREACH IS A SUBCOMMITTEE OF GCDE, AND WE'RE THE COMMUNITY OUTREACH SUBCOMMITTEE, AND WE'RE THE ONES HOPING TO WORK WITH LOCAL PARTNERS -- (INAUDIBLE).

I THINK, IDEALLY, IT WOULD BE ONE FLYER, NOT REALLY SURE HOW WE DO THAT. I WOULD ASSUME -- ALTHOUGH, I'M -- WE NEED TO CHECK THE -- I'M KIND OF ASSUMING THAT GCDE TYPICALLY DOES A FLYER. I SEE AMY'S HAND. MAYBE SHE HAS INFORMATION.

AMY: THIS IS AMY. ACTUALLY, I BET RYAN DOES. BUT I WAS GOING TO SAY, SOME OF THE OTHER COMMITTEES I'M ON, SOMETIMES THE STATES THAT WE ARE UNDER -- THEY ACTUALLY HAVE A COMMUNICATIONS TEAM, AND SOMETIMES WE INITIATE WHAT WE WOULD LIKE TO SEE, AND THEY FINISH IT, AND I THINK WE INITIATE AND TAKE IT TO COMPLETION, BUT I THINK -- I'M SEEING RYAN ON HERE, AND I BET HE KNOWS BEST.

MARSHA: DO YOU WANT TO SAY SOMETHING?

RYAN: YES. THIS IS RYAN, IF I MAY?

YES. IVY ANN -- IS A MEMBER -- FOR WORK WITH GCDE, AND I AM DEAF-BLIND, AND I DO WANT YOU TO KNOW THAT. GCDE HAS DOES MANY FLYERS IN THE PAST, AND WE HAVE TEMPLATES FOR THEM. AND FOR THE COMMUNITY OUTREACH WE DO HAVE A TEMPLATE THAT WE USE IN ORDER TO ADVERTISE FOR OUR COMMUNITY OUTREACH EVENT. WE WANT A TEMPLATE THAT'S GEARED TOWARD COMMUNITY MEMBERS, ONE THAT IS GEARED TOWARD THE COUNTY, OFFICIALS, AND STAFF FOLKS, YES, OFFICIALS, ELECTED OFFICIALS THAT IS.

AND THEN WE HAVE A DIFFERENT TYPE OF TEMPLATE FOR THE SCHOOL DISTRICTS AND SO FORTH, AS WE DO HAVE DIFFERENT TEMPLATES THAT WE'RE ABLE TO USE FOR HUMAN SERVICES ORGANIZATIONS, ET CETERA. AND WE ALSO HAVE A GENERAL FLYER TO SEND OUT TO THE COMMUNITY.

MARSHA: OKAY. THAT SOUNDS GOOD. SHOULD COVER JUST ABOUT --

RYAN: AND THAT WILL ALSO COVER RADIO, AND TV, AND SOCIAL MEDIA. SO, YES, WE HAVE THE MEANS TO GET THE WORD OUT.

MARSHA: OKAY. GREAT.

SO HOPEFULLY WE WILL USE OUR GCDE CHANNELS, AND THEN, ALSO, PEOPLE WHO ARE IN THE COMMUNITY CAN USE THEIR CHANNELS, AND THAT WAY WE CAN MAKE SURE THAT WE COVER EVERYTHING.

CARLEY: MARSHA, THIS IS CARLEY, AGAIN.

I HAVE CERTAIN PEOPLE THAT I AM GOING TO TRY AND INVITE. AS FAR AS COMMUNITY MEMBERS, CITY COUNCIL, AND COMMISSIONERS, DO THEY NEED THAT FLYER BEFORE I INVITE THEM? OR CAN I JUST -- SOMEONE IS GOING TO HELP ME KIND OF (INAUDIBLE) BUT DO I NEED TO PRESENT A FLYER TO THEM FIRST BEFORE I EXTEND AN INVITATION?

RYAN: CARLEY, YOU'RE ASKING A GOOD QUESTION. NORMALLY WHAT WE DO IS WE RESEARCH AND FIND OUT, FOR EXAMPLE, IN KITSAP COUNTY THAT MARSHA HAD MENTIONED, WE WERE IN PORT ORCHARD, SO WE RESEARCHED WHO THE ELECTED OFFICIALS WERE IN THAT AREA, ET CETERA, AND ON THE IMPORTANT CITY COUNCIL PEOPLE, AND WE WROTE TO THEM.

WE HAVE A LETTER TEMPLATE AS WELL WITH THE SPECIFIC INFORMATION THAT WE SEND TO THE ELECTED OFFICIALS, AND WE E-MAIL THAT LETTER OUT TO EVERYONE, AND ASK THEM TO FOLLOW UP, AND WE FOLLOW UP WITH THEM, AND IF THEY DON'T REACH OUT TO US, AND WE KEEP THEM IN THE LOOP AND THEY'RE PART OF THE PROCESS. SO THEY KNOW THEY'RE INVITED.

CARLEY: WELL, THE REASON I ASK, RYAN, IS BECAUSE I'M INVOLVED IN A LOT OF POLITICAL THINGS RIGHT NOW. I'M EVEN VOLUNTEERING FOR A CANDIDATE FOR 2024, SO I'M LOCALLY AND NATIONALLY INVOLVED A LOT. SO I KNOW PEOPLE (INAUDIBLE) OR AT LEAST GETTING TO KNOW A LOT OF THESE PEOPLE PERSONALLY, SO I NEEDED TO KNOW PROFESSIONALLY AS HOW YOU WANTED ME TO HANDLE IT. DOES THAT MAKE SENSE?

DO YOU STILL WANT ME TO PRESENT THE LETTER TO THEM? OR JUST TALK TO THEM?

MARSHA: MY SUGGESTION WOULD BE THAT WHEN YOU HAPPEN TO ENCOUNTER THEM, MAYBE JUST DO KIND OF A SAVE-THE-DATE THING, SAY WE HAVE THIS THING COMING THAT'S GOING TO HAPPEN AT THE BEGINNING OF NOVEMBER, IF YOU COULD GET IT ON YOUR END, AND WE WILL FOLLOW UP WITH MORE INFORMATION LATER, AND THAT WAY WHEN WE HAVE LETTER AND/OR THE FLYER, YOU CAN FORWARD THAT ON TO THEM.

CARLEY: OKAY. THAT MAKES SENSE.

MARSHA: OKAY. LET'S SEE. WHERE IS LILLEY?

DID LILLEY LEAVE US?

SHE WAS GOING TO TALK ABOUT CATERING.

CARLEY: I THINK -- THIS IS CARLEY AGAIN, I THINK I HEARD HER GO OFF.

MARSHA: OKAY. ALL RIGHT.

WELL, ALL RIGHT. YEAH. SHE'S BEEN LOOKING INTO THE CATERING AND HAS INFORMATION ON I THINK -- OH, BOY, MY MEMORY IS THAT SHE FOUND OUT THAT CLARK COLLEGE ONLY DOES THE CATERING IF YOU'RE HAVING A MEETING AT THEIR -- ON THEIR CAMPUS. AND PAPER TIGER DO A FULL CONTINENTAL BREAKFAST. THEY JUST DO COFFEE AND, I THINK, DOUGHNUTS

CARLEY: THIS IS JUST A -- SORRY. THIS IS CARLEY, AGAIN. THIS IS A SUGGESTION. BUT WHAT ABOUT, LIKE A LOCAL FOOD TRUCK? NOT FIVE OR TEN. BUT WHAT IF WE JUST HAD THE LOCAL FOOD TRUCK OUTSIDE THE BUILDING WHERE PEOPLE COULD ORDER WHAT THEY WANTED? HOW MUCH DO YOU THINK THAT WOULD COST US, IF ANY? WOULD A LOCAL FOOD TRUCK BE BETTER? OR WORSE?

MARSHA: I'M NOT REALLY LIKING THAT IDEA OFFHAND, FOR A COUPLE REASONS. ONE IS THAT WE KIND OF WANT PEOPLE IN THE ROOM, YOU KNOW. THERE IS A LOT OF EXCHANGE THAT HAPPENS WHILE PEOPLE ARE GETTING THEIR STUFF AND TAKING IT OVER TO THEIR TABLE, AND, YOU KNOW, ALL THAT. AND I THINK HAVING TO GO OUTSIDE TO GET STUFF WOULD BE A LOT MORE DISRUPTIVE. PEOPLE WOULD PROBABLY WANT REFILLS, OR COFFEE, AND THAT KIND OF THING.

AND MY OTHER CONCERN IS POTENTIALLY COULD BE A LOT HARDER TO CONTROL COSTS WITH A FOOD TRUCK. I REALLY WOULD, QUITE STRONGLY, PREFER TO HAVE THE FOOD IN THE ROOM, IF POSSIBLE.

I MEAN, I'M NOT WORRIED ABOUT THIS. I'M SURE IT WILL GET STRAIGHTENED OUT. I KNOW -- I MEAN, I WAS LIKING OF TRYING TO WORK WITH SOMEBODY LOCAL, POSSIBLY AN ORGANIZATION THAT EMPLOYED PEOPLE WITH DISABILITIES. IT DOESN'T LOOK LIKE WE'RE GOING TO BE ABLE TO -- OR POSSIBLY AN ORGANIZATION FROM THE BIPOC COMMUNITY. SO FAR I'M NOT SURE WE'LL BE ABLE TO PULL THAT OFF. MY UNDERSTANDING IS THAT THEY -- (INAUDIBLE) HAS A CONTRACT WITH PANERA, AND THEY'RE IN CLARK COUNTY. SO IF PUSH COMES TO SHOVE, I'M ASSUMING WE CAN DO THAT.

CARLEY: THAT'S AN OPTION.

MARSHA: I WANT TO -- RYAN, DO YOU WANT TO ADD ANYTHING?

RYAN: YES. THIS IS RYAN SPEAKING.

I THINK WE HAVE MORE CHOICES THAN JUST PANERA, BUT I HAVEN'T CHECKED THE CONTRACT SYSTEM AS OF YET TO SEE WHO IS ON THE BENDER LIST. BUT I THINK THERE IS MORE THAN JUST PANERA AS AN OPTION

MARSHA: OKAY.

RYAN: THERE'S ALSO SAFEWAY AND QFC, BUT I DON'T KNOW OF ANY LOCAL RESTAURANTS, BECAUSE I'VE NEVER WORKED IN PERSON THERE BEFORE.

MARSHA: RIGHT.

RYAN: AND FOR THE LAST TWO YEARS, WE'VE ALL BEEN ON VIDEO. SO I THINK BEST IS TO CHECK THE SYSTEM AND SEE WHO IS ON THE CURRENT VENDOR LIST.

MARSHA: OKAY. IF YOU COULD DO THAT, THAT WOULD BE HELPFUL.

RYAN: BIPOC, OR AN ORGANIZATION, OR AN ORGANIZATION WITH DISABLED PEOPLE, OR DISABLED-OWNED WOULD BE GREAT. THAT, I THINK, WOULD BE OUR FIRST CHOICE. BUT WE WILL SEE WHAT WE CAN DO, AND IF WE NEED TO RELY ON THE LIST -- VENDOR LIST, I THINK WE CAN, BUT I THINK WE WANT TO EXPLORE OTHER THINGS AT FIRST.

MARSHA: AT THIS POINT IN THE GAME, I'M COMFORTABLE WAITING A LITTLE BIT ON THIS SINCE WE KNOW WE HAVE A FALL-BACK POSITION OF PANERA, IF ANYTHING THAT DOESN'T WORK.

I'M ACTUALLY MORE CONCERNED ABOUT GETTING THE TRANSPORTATION IN PLACE. AND THAT'S WHY I WAS HOPING ZACH WAS GOING TO BE HERE, BECAUSE HE WAS THE ONE THAT SAID HE WOULD FOLLOW UP ON THAT.

WE'VE TALKED ABOUT -- ACTUALLY, AT THE LAST MEETING, WE TALKED QUITE A BIT ABOUT WHO WAS GOING TO INVITE WHO.

THE OTHER THING WE TALKED ABOUT, I SEE DAVE CARL'S HAND. HE WAS ALSO GOING TO TALK TO C-TRAN, AS I RECALL.

DAVE: THIS IS DAVE. AND, YES, I DID TALK TO C-TRAN, AND THEY SEEMED QUITE INTERESTED IN BEING INVOLVED WITH ITS -- THEY GAVE -- THEY SAID THAT IT'S POSSIBLE THAT THEY COULD DO SOMETHING WHERE IT'S, YOU KNOW MORE, LIKE A -- SOMETHING THAT TRAVELS AROUND LIKE A BUS. BUT THEN THAT THEY'RE -- WELL, THERE IS SOMETHING -- IT'S A SPECIFIC TYPE -- IT'S CALLED THE CURRENT. AND THE CURRENT IS -- IT'S PRETTY -- IT'S ALMOST IDENTICAL TO UBER, AND THAT'S BEEN -- I MEAN, IT'S VERY -- THERE AREN'T VERY MANY, BUT IT'S STILL AN OPTION. AND, I MEAN, I'VE USED THE CURRENT MYSELF, AND IT'S QUITE GOOD.

SO THESE ARE AT LEAST SOME OPTIONS. THEY -- LIKE I SAID, THEY SEEM -- THEY SEEMED SOMEWHAT PROMISING FOR BEING ABLE TO ACCOMMODATE AND BEING ABLE TO -- WILLING TO HELP OUT. THEY WOULD JUST NEED TO GET MORE DETAILS AS TIME GOES ON.

MARSHA: OKAY. SO THAT IS ENCOURAGING. I'M GUESSING THAT THE CURRENT IS WHAT -- IN SOME PLACES CALLED A DIAL-A-RIDE. YOU CAN CALL THEM UP, AND SAY I NEED TO GO FROM THIS PLACE TO THAT PLACE, AND THEY -- BUT IT'S A BUS, AND ITS WHEELCHAIR ACCESSIBLE.

DAVE: IT'S NOT A BUS. IT'S MORE OF A VAN.

MARSHA: OKAY. BUT THE VAN IS --

DAVE: YES. THE VAN IS DEFINITELY ACCESSIBLE. IT HAS TO BE ACCESSIBLE. THAT'S UNDER THE ADA. BUT, I MEAN, IT'S NOT THE SAME, WHEN I THINK OF DIAL-A-RIDE I THINK OF IT'S THE PARATRANSIT. IT'S NOT THE PARATRANSIT. ANYBODY CAN RIDE IT.

MARSHA: YEAH. THAT'S WHAT DIAL-A-RIDE IS.

DAVE: YEAH. THIS IS SOMETHING CLARK COUNTY OR C-TRAN, THE C-VAN, WHICH IS THE PARATRANSIT, AND, IN ADDITION, THEY HAVE THE CURRENT, AND IT'S NOT -- EVERYWHERE, IT'S LIMITED, BUT IT IS STILL, LIKE I SAID, IT IS STILL AT LEAST SOMETHING IN ADDITION.

MARSHA: OKAY.

CARLEY: THIS IS CARLEY. I WANTED TO JUST PUT A SUGGESTION OUT THERE. I NO LONGER USE C-VAN ANYMORE, BUT I DID FOR ABOUT SIX MONTHS, AND FOR THOSE THAT WANT TO RIDE IT, BEING AWARE OF THE HALF-AN-HOUR WINDOW THAT BUS IS PICKING YOU UP, IF OUR MEETING IS AT 6:30, AND THEY DON'T GET THERE UNTIL 7:00, YOU -- AND MORE AHEAD OF THE MEETING IS NOT GOING TO WORK.

SO JUST BE AWARE OF THAT WHEN YOU'RE -- IF YOU DO NEED A RIDE. IF WE END UP GOING WITH THE VAN, THAT'S GREAT. BUT IF WE HAVE TO STICK WITH C-VAN, THAT'S JUST SOMETHING YOU NEED TO BE AWARE OF.

MARSHA: YEAH. I WOULD REALLY LIKE US TO SEE US PUT A LOT OF WORK IN MAKING THE TRANSPORTATION REAL WELL FOR AS MANY PEOPLE AS POSSIBLE.

AND I SEE AMY'S HAND.

AMY: THIS IS AMY. I APPRECIATE WHAT CARLEY SAID HERE TODAY, AND ESPECIALLY WITH THAT WINDOW WHERE YOU DON'T KNOW IF YOU'RE GOING TO GET THERE AT 6:00, AT 6:30, AT 7:00. AND I'M THINK MAKE TO ENCOURAGE PEOPLE

TO BOOK A TIME THAT MIGHT GET THEM THERE BY 6:30, THAT'S WHEN WE WOULD START, THAT WE MIGHT HAVE SOMETHING THAT'S AVAILABLE STARTING AT 6:00 FOR THE FOLKS WHO DO GET DROPPED OFF THAT EARLY, SOMETHING THAT WOULD BE ENGAGING AND BRING VALUE FOR THEM AND FOR US, BUT NOT LEAVE FOLKS, DO TAKE THE INITIATIVE TO GET THERE EARLY OR ON TIME, NOT LEAVE KIND OF THEM HANGING, NO VALUE FOR THEIR TIME.

MARSHA: I SEE DAVE, AND THEN LILLEY.

DAVE: YEAH. THIS IS DAVE. AND I RIDE C-VAN ALL THE TIME, AND I ALMOST NEVER HAVE A PICK UP TIME. I ALMOST ALWAYS DO IT AS AN APPOINTMENT TIME.

LILLEY: EXACTLY.

DAVE: SO THAT IS ONE THING THAT I WOULD DO, JUST TO MAKE SURE THAT WHEN YOU SCHEDULE IT, YOU DON'T SAY THAT, I WANT TO BE PICKED UP AT 5:00, SAY THAT I NEED TO BE THERE NO LATER THAN 6:00, OR NO LATER THAN WHATEVER TIME YOU WANT TO, ACTUALLY, OFFICIALLY BE THERE. SO I DO THAT ALL THE TIME. I HAVE TO DO THAT FOR WORK. I HAVE TO DO THAT FOR APPOINTMENTS. AND THAT'S ONE THING THEY DO ALLOW.

MARSHA: OKAY. RYAN, CAN YOU MAKE A POINT OF REALLY HIGHLIGHTING THAT AND MAKING SURE THAT WE INCLUDE THAT IN ANYTHING THAT GOES OUT TO THE COMMUNITY, PLEASE?

LILLEY: YEAH. I LIKE THAT. THAT'S EXACTLY WHAT I WAS GOING TO SAY -- (INAUDIBLE) THEN THEY WILL GET YOU KNOW LATER THERE THAN 6:30 YOU MIGHT BE EARLY. WHEN YOU'RE DONE, THEY -- I WANT TO BE PICKED UP NO LATER -- NO EARLIER THAN 9:00. THEN THEY WILL COME UP, YOU KNOW, THE HALF-HOUR WINDOW WILL BEGIN AFTER THOSE TIMES.

AND SO YOU MIGHT BE WAITING A HALF-HOUR JUST TO GET ON THE BUS, YOU KNOW, BUT YOU WON'T BE THERE LATE, IF YOU TELL THEM MY APPOINTMENT IS AT X TIME. AND THEN THE OTHER THING IS THAT THEY CAN GO AROUND FOR AN HOUR, YOU WILL GET THERE. I'VE NEVER BEEN LATE. I'VE USED IT FOR OVER TEN YEARS, ACTUALLY OVER -- A LONG TIME. SO I'VE NEVER BEEN LATE ON THINGS.

THERE WAS ANOTHER THING. I WAS GOING TO MENTION ON -- WE DON'T KNOW FOR SURE, LIKE, RIGHT NOW IF IT'S GOING TO START AT 6:30, BECAUSE MICHELLE FENTI (PHONETIC) AT THE COUNTY IS STILL WORKING ON POSSIBLY MAKING IT TO BE EARLIER. WE'LL SEE. AND THE OTHER THING IS WHEN SHE DOES COME UP WITH A FINAL TIME, SHE'LL, ALSO -- WITH THAT E-MAIL, SHE'LL SEND CONFIRMATION, WILL LET US KNOW THE ADDRESS AND EVERYTHING OF THE HEARING ROOM

MARSHA: OKAY. GREAT.

LILLEY: AND I'M SORRY FOR DISAPPEARING. MY COMPUTER SHUTDOWN.

MARSHA: WE DID WONDER.

LILLEY: IT'S A SLOW COMPUTER. SO I APOLOGIZE.

MARSHA: WELCOME BACK.

RYAN WANTS TO SAY SOMETHING? OKAY.

RYAN: YES. THIS IS RYAN SPEAKING. THERE ARE A LOT OF THINGS WE GOT TO CHECK ON, THINGS THAT WE'RE CONSIDERING. ONE OF THEM IS THE OLD FLYER, AND WE HAD THE FLYER BEFORE COVID HIT, AND THAT TALKED ABOUT TRANSPORTATION, SO -- AND IT TALKED ABOUT THE TIME THAT YOU NEED TO BUILD IN TO ARRIVE ON TIME, THAT SORT OF THING, WHICH IS WHAT YOU MENTIONED. SO WE CAN RESURRECT THAT OR RECREATE A FLYER THAT INCLUDES THAT.

AGAIN, ANOTHER THING THAT HAPPENED BEFORE COVID BECAUSE OF OUR SITUATION IN THE LAST COUPLE YEARS, THE TEMPLATES HAVE BEEN ACCOMMODATING A VIRTUAL MEETING AS OPPOSED TO ON-SITE. AND SO ANOTHER THING THAT WE TALKED ABOUT WAS THE FOOD, AND WE HAVE SNACKS DURING THE MEETING FOR -- WE HAVE WATER, SNACKS, AND THAT TYPE OF THING.

LILLEY: THAT'S THE SECOND MEETING; RIGHT?

MARSHA: I'M THINKING IT'S THE FIRST MEETING.

LILLEY: THE FIRST MEETING TOO? OKAY.

RYAN: THE TOWN HALL MEETING, IS WHAT I'M TALKING ABOUT. THE BREAKFAST, THE FOLLOWING MORNING, THE BREAKFAST IS DIFFERENT AND DIFFERENT FORMAT FOR FOOD.

LILLEY: OKAY.

MARSHA: AND WE DID TALK ABOUT THAT, LILLEY, WHEN YOU WERE GONE, AND I HOPE I PRESENTED YOUR INFORMATION CORRECTLY THAT CLARK COLLEGE DOES NOT CATER THINGS THAT ARE NOT ON THEIR --

LILLEY: CORRECT.

MARSHA: AND PAPER TIGER ONLY HAS COFFEE AND DOUGHNUTS. AND RYAN IS GOING TO LOOK INTO WHO, BESIDES PANERA HAS EXISTING CONTRACTS WITH THE STATE.

LILLEY: OKAY. CHUCK'S PRODUCE IS A GOOD OPTION TO CATER THAN THE LOCAL PANERAS, AND THEY PROVIDE, NOT JUST BAKERY ITEMS, IT WOULD BE, ACTUALLY A BOILED EGG, AND THERE SEEMS TO BE SOME PROTEIN IN THERE, TOO, AND THEY WERE A LITTLE BIT LESS THAN -- BUT IT'S AN OPTION. IT'S A LOCAL GROCERY STORE. CHUCK'S PRODUCE. IT'S AN OPTION.

MARSHA: YEAH. I MEAN, AS I SAID, MY PREFERENCE, IN THE BEST OF ALL POSSIBLE WORLDS, A COMPANY THAT EMPLOYS PEOPLE WITH DISABILITIES OR A COMPANY RELATED TO THE BIPOC COMMUNITY, BUT IF WE DON'T HAVE THOSE OPTIONS, YOU KNOW, THEN WE LOOK ELSEWHERE. AND IF WE'RE GOING TO GO WITH SOMETHING LIKE CHUCK'S PRODUCE, THEN I'M GUESSING JUST NOT HAVE AN EXISTING CONTRACT WITH THE STATE, WE NEED TO START ON THAT SOONER RATHER THAN LATER, BECAUSE I KNOW WE HAVE TO JUMP THROUGH ALL THE HOOPS.

LILLEY: AND MARSHA, I DID E-MAIL YOU WHAT CHUCK'S SENT ME FOR WHOEVER NEEDS IT, IF WE GO THAT WAY. THEY CAME IN -- THEY WERE -- THEY WERE SUPPLYING BETWEEN 48 AND -- 48 AND 62 MEALS, YOU KNOW, BREAKFAST. SO WHAT WE -- WE HAD SAID 40, I THOUGHT. SO IT WAS ACTUALLY -- SO IT LOOKS MORE EXPENSIVE THAN IT IS, IF YOU LOOK AT THE SHEET THAT THEY SENT.

MARSHA: THANKS. I MISSED THAT. I WILL HAVE TO GO BACK AND FIND IT. THANK YOU FOR THE HEADS UP. OKAY. JUST TO TAG ONE MORE THING ON TO THE TRANSPORTATION QUESTION. DAVE, IT SOUNDS LIKE YOU'RE GOING TO BE OUR MAIN CONTACT WITH C-TRAN?

DAVE: THIS IS DAVE. SURE.

MARSHA: OKAY. I'M HOPING THAT WHEN WE TALK TO THEM AND ALSO PRESENT IT AS AN OPPORTUNITY FOR THEM, INTRODUCE THEIR SERVICE TO PEOPLE WHO MAY NOT ALREADY BE FAMILIAR WITH IT, AND HOPEFULLY, YOU KNOW, BUILD THEIR CUSTOMER BASE BY GIVING PEOPLE A GOOD EXPERIENCE, IF THAT MAKES SENSE.

DAVE: THAT WOULD BE GREAT. DEFINITELY.

MARSHA: IF YOU TAKE THAT APPROACH, MAYBE THAT WOULD ENCOURAGE THEM. AND I THINK RYAN WANTS TO SPEAK. AM I RIGHT?

RYAN: YEAH. IF I CAN ASK A CLARIFYING QUESTION. YOU KEEP USING THE WORD TRAN, ARE YOU TALKING ABOUT -- IS IT -- IT'S SPELLED TO ME AS S-E-A-T-R-A-N. OR IS IT THE LETTER C-T-N.

DAVE: IT'S THE LETTER C.

RYAN: CLARK COUNTY.

DAVE: YEAH. LIKE CLARK COUNTY, SO IT'S THE LETTER C-T-R-A-N.

LAURIE: AND THAT'S AN INTERPRETER ERROR. MY OPPOSES. I WROTE IT AS S-E-A, MAYBE BECAUSE I'M IN SEATTLE.

DAVE: THE C-VAN THAT I KEEP ON MENTIONING, THAT'S THE LETTER C-V-A-N.

LILLEY: I ALREADY FORGOT MY QUESTION.

I REMEMBER NOW.

PATRICIA BUESCHER, WHO IS THE STAFF MEMBER THAT COORDINATES WITH THE BOARD FOR DEVELOPMENTALLY DELAYED HERE IN CLARK COUNTY ACTUALLY REQUESTED THAT SHE IS INVITED, WHICH I'M SURE THEY'RE -- AND THE THING WITH THE AC, AC, THAT HAS TO BE A CLARK COUNTY -- A COUNTY PERSON HAS TO REQUEST THAT TO BE ESTABLISHED. SO TRISH MIGHT BE OUR GIRL, YOU KNOW. THAT MIGHT BE A REALLY GOOD -- THAT MIGHT BE A RELATIONSHIP.

MARSHA: I DON'T THINK THAT'S ACCURATE, LILLEY.

LILLEY: OH, REALLY? I DON'T HAVE TO BE A CLARK EMPLOYEE?

MARSHA: YEAH.

LILLEY: OH. I DIDN'T KNOW THAT.

MARSHA: THE ONE HERE, I WAS THE ONE WHO WENT TO THE COMMISSIONERS AND ASKED THAT IT BE SET UP, AND THEN THEY DECIDED WHAT DEPARTMENT SHOULD WORK WITH IT, WHICH IN OUR CASE IS HUMAN SERVICES.

LILLEY: BUT IT'S SOMEBODY IN KITSAP COUNTY, THOUGH, RIGHT, THAT HAS TO SET IT UP?

MARSHA: LIKE A STAFF CONNECTION. AND I SEE --

LILLEY: RIGHT. THAT'S WHAT I'M SEEING. IT MIGHT BE OUR STAFF PERSON, IS WHAT I'M SAYING FOR THIS. AND THIS IS JUMPING TO THE FUTURE.

MARSHA: YEAH. AND I THINK THAT'S A WHOLE DISCUSSION. BUT SINCE I SEE ELIZABETH'S HAND, SHE HAS A MUCH BETTER GRASP ON THIS THAN I DO, I WILL CALL ON HER.

ELIZABETH: HI, EVERYBODY. I WANTED TO SHARE, I THINK I'VE SEEN THEM SET UP BOTH WAYS WHERE THE -- COMES TOGETHER AND STARTS ONE, OR THE COUNTY STARTS IT. IF YOU DON'T HAVE THE RELATIONSHIP WITH THE COUNTY,

YOU'RE CORRECT LILLEY, IF YOU'RE MISSING THE RELATIONSHIP WITH THE COUNTY, YOU CANNOT GET YOUR PROJECTS DONE.

AND SO I THINK IT'S REALLY STRATEGICALLY SMART TO HAVE A COUNTY PERSON GET INVESTED AS EARLY AS POSSIBLE, ESPECIALLY IF THAT'S OUR GOAL.

WE'VE HAD A COUPLE OF ACACS WHERE THE COMMUNITY HAS COME TOGETHER AND THEY HAVE A LOT OF RELATIONSHIP WITH THE COUNTY, AND IT MAKES IT REALLY IMPOSSIBLE TO DO THE PROJECTS BECAUSE WE'RE REQUIRED BY STATUTE TO DO OUR CONTRACTING WITH THE COUNTY, SO EVEN THOUGH WE'VE AWARDED FUNDS, WE HAVEN'T BEEN ABLE TO GET THE PROJECTS DONE BECAUSE WE DON'T HAVE THAT COUNTY RELATIONSHIP. SO IT'S REALLY ABOUT THAT REALLY NICE CONNECTION THERE. IT NEEDS TO BE A PARTNERSHIP. AND SO I THINK THAT'S REALLY GOOD STRATEGIC THINKING, AND I'LL STEP BACK NOW.

LILLEY: THANK YOU.

MARSHA: YEAH. I DON'T WANT TO SPEND TOO MUCH TIME ON THIS, ACTUALLY, I CAN'T TIE THIS -- MY WATCH. MY CONCERN ABOUT HAVING DEVELOPMENTAL DISABILITIES PEOPLE BE THE ONES IN CHARGE OF IT IS THAT TYPICALLY, THEY'RE A REALLY LARGE ESTABLISHED ORGANIZATION, IF YOU WILL, ALREADY, AND THEY'RE ONE -- THEY'RE ONE PART OF WHO ARE THE PEOPLE WITH DISABILITIES, BUT THERE ARE ALSO A LOT OF PEOPLE THAT THEY DON'T REPRESENT --

LILLEY: RIGHT.

MARSHA: -- PEOPLE IN WHEELCHAIRS, PEOPLE, WHO ARE BLIND, PEOPLE WHO ARE DEAF.

LILLEY: NO. I WASN'T SUGGESTING THAT THEY TAKE IT OVER. I WAS SUGGESTING THAT SHE BE THE INITIAL CONTACT TO CREATE AN ACAC WARD, WHICH WOULD REPRESENT EVERYBODY; RIGHT? THAT'S WHAT I WAS THINKING.

MARSHA: RIGHT. OKAY. I THINK WHAT WE NEED TO DO IS KEEP THIS IN MIND GOING FORWARD, IT'S PROBABLY NOT WHAT WE WANT TO FOCUS ON AT THE MOMENT. I -- I SEE MATT'S HAND.

MATT: YEAH. MARSHA. THIS IS MATT. TWO THINGS, ONE IS IT'S 4:48, AND SO NOW YOU CAN KNOW.

THE OTHER THING IS I WANT TO LET YOU KNOW DANIEL L. JUST SHOWED UP AS WELL.

MARSHA: OH, HE SHOWED UP A WHILE AGO, I THOUGHT. I'VE SEEN HIM HERE FOR A WHILE.

MATT: I THOUGHT I JUST SAW HIM POP UP TO MY SCREEN. NEVER MIND.

MARSHA: AND I ALSO THINK THAT WE NEED TO AWARD ERIC SOME DOG POINTS FOR HAVING HIS DOG IN THE MEETING BRIEFLY. THAT ALWAYS MAKES A MEETING BETTER, IN MY ESTIMATION.

OKAY. SO WE HAVE ABOUT TEN MINUTES LEFT. AND I'M FEELING MUCH BETTER ABOUT THIS THAN I WAS AT THE MEETING A WEEK AGO, BECAUSE -- IS RYAN TRYING TO SAY SOMETHING? I CAN'T TELL.

RYAN: THIS IS RYAN. YES. I DO. I WANTED TO ASK LILLEY A QUESTION -- EITHER CARLEY OR LILLEY. THE NAME OF THE BUILDING THAT IS GOING TO HOST THE MEETING, DID YOU SAY SOMETHING LIKE CLARK COUNTY BUILDING? IS THAT WHAT -- HOW YOU NAMED IT?

LILLEY: IT'S THE CLARK COUNTY HEARINGS BOARD ROOM IS THE NAME OF THE ROOM. IT IS A COUNTY BUILDING, BUT I'M NOT SURE, YOU KNOW -- I'M NOT SURE THE OFFICIAL NAME OF IT.

CARLEY: THIS IS CARLEY. THIS IS PROBABLY -- WE HAVE IT FOR BOTH DAYS, AND IT'S FREE.

LILLEY: CORRECT.

CARLEY: AND IT'S FREE. WE DON'T HAVE TO -- (INAUDIBLE).

LILLEY: SHE'S GOING TO SEND US ALL THE INFORMATION BY FRIDAY. WE WILL HAVE AN OFFICIAL NAME OF THE BUILDING, AND THE ROOM NUMBER, AND ALL THAT STUFF, BUT I --

LAURIE: OKAY. THIS IS THE INTERPRETER. I'M SORRY. TWO PEOPLE ARE TALKING AT THE SAME TIME, RYAN AND YOU'RE BOTH TALKING AT THE SAME TIME.

LILLEY: I'M SORRY.

LAURIE: RYAN HAS ASKED...

RYAN: WHEN YOU HAVE AN OPPORTUNITY, CAN YOU SEND ME THE CONTACT NAME OF THE PERSON AT THE COUNTY HEARING ROOM SO I CAN BE IN COMMUNICATION WITH THEM?

LILLEY: I CAN SEND THAT TO -- MARSHA, AND MARSHA CAN DISTRIBUTE IT TO WHOEVER SHE WANTS TO. DOES THAT WORK?

MARSHA: SURE, ALTHOUGH, I'M HAPPY TO SEND IT DIRECTLY TO RYAN.

LILLEY: OKAY. ALL RIGHT.

MARSHA: I DO NOT NEED TO BE A POTENTIAL BLOCK IN THE INFORMATION CHANNEL. THAT IS NOT MY DESIRE.

OKAY. SO GOING FORWARD FROM HERE, WE NEED TO -- THANK YOU SO MUCH.

FOR THE TRANSPORTATION STUFF.

OH, I SEE RYAN ASKING TO SPEAK?



RYAN: I'M SORRY. THIS IS RYAN, AGAIN. LILLEY, THE REASON I'M ASKING FOR THAT IS WE WILL NEED TO HAVE SOME SORT OF WRITTEN AGREEMENT. EVEN IF THERE IS NO MONEY EXCHANGE, WE WANT TO HAVE A WRITTEN AGREEMENT. AND SO THE STATE WANTS TO MAKE SURE WE'VE DOTTED OUR IS AND CROSSED OUR TS. AND SO THAT WOULD BE HELPFUL FOR ME TO GET INTO THAT LOOP IN ORDER TO GET THAT IN PLACE FOR ALL OF US.

LILLEY: AND AT THIS POINT I ONLY HAVE HER PHONE NUMBER. I DON'T HAVE HER E-MAIL ADDRESS. ON FRIDAY, I SHOULD HAVE HER E-MAIL ADDRESS. SO DO YOU WANT ME TO JUST SEND YOU THE PHONE NUMBER NOW, AND THEN LATER THE E-MAIL ADDRESS? OR WHAT WOULD YOU LIKE ME TO DO?

RYAN: YES. FRIDAY IS FINE.

LILLEY: OKAY.

RYAN: YEAH.

IF YOU COULD E-MAIL AND PHONE NUMBER BY FRIDAY, THAT WOULD BE GREAT.

LILLEY: OKAY. I HAVE TO LEAVE. I HAVE ANOTHER MEETING COMING UP.

MARSHA: OKAY. THANK YOU.

OKAY. SO REVIEWING WHAT WE NEED TO GET DONE, THERE IS THE FOOD. THERE IS TRANSPORTATION. THERE IS PUBLICITY. WE'VE TOUCHED ON ALL OF THOSE.

WE HAVEN'T TOUCHED ON INTERPRETERS. SO I'M NOT SURE AT WHAT POINT -- AND RYAN, ARE YOU GOING TO TAKE CARE OF ALL THE INTERPRETERS? OR DO WE NEED TO BE INVOLVED IN THAT?

RYAN: RYAN SPEAKING. NORMALLY WE WORK OUT THE ACCOMMODATIONS FOR ALL OF THE EVENTS. YEAH. THAT'S SOMETHING WE'LL -- INCLUDING CART WRITERS, AND INTERPRETERS, AND ANYTHING REGARDING ACCOMMODATIONS, THAT'S SOMETHING WE'LL TAKE CARE OF.

MARSHA: AND SO THEN THE OTHER PIECE OF LOCAL WORK THAT I THINK HAS TO GET DONE IS THAT WE NEED TO FIND A PLACE FOR GCDE MEMBERS, SUBCOMMITTEE MEMBERS, WHO ARE COMING OUT OF CLARK COUNTY TO STAY OVERNIGHT ON THURSDAY NIGHT; IS THAT RIGHT?

I SEE CARLEY'S HAND.

CARLEY: CARLEY, I HAVE A QUICK QUESTION. SO I GOT THE IMPRESSION, AND I MAY BE WRONG, THIS ONE IS A CLARK COUNTY -- (INAUDIBLE) ARE WE INVITING PEOPLE FROM ACROSS THE STATE, FOR EVERY COUNTY?

MARSHA: NO. NO. NO. NO. NO.

CARLEY: OKAY.

MARSHA: THE PEOPLE THAT WILL NEED ACCOMMODATIONS ARE MEMBERS OF THE GCDE SUBCOMMITTEE ON COMMUNITY OUTREACH. SO THAT WOULD BE PEOPLE -- DAVE IS SORT OF IN BOTH CATEGORIES, BUT THAT WOULD INCLUDE RYAN, AND ELIZABETH, AND AMY, AND MATT, AND IVY ANN, AND AT LEAST TWO MORE PEOPLE NOT HERE AT THE MOMENT. AND OBVIOUSLY WE NEED TO FIND A PLACE THAT WILL ACCEPT THE GOVERNMENT RATE FOR US TO STAY. WE ALSO NEED TO MAKE SURE THAT IT HAS APPROPRIATE ACCOMMODATIONS, YOU KNOW. IN OTHER WORDS, IT SOME WHEELCHAIR-ACCESSIBLE ROOMS, THAT IT HAS ROOMS FOR PEOPLE WHO ARE BLIND, THAT IT HAS SOME ROOMS FOR PEOPLE WHO ARE DEAF, HEARING IMPAIRED.

CARLEY: SO WE'RE NOT TALKING ABOUT INVITING PEOPLE FROM EVERY -- (INAUDIBLE) HOW WE'RE NOT TALKING ABOUT INVITING PEOPLE FROM EVERY COUNTY THEN?

MARSHA: NO.

CARLEY: I WAS CONFUSED WHEN YOU SAID -- (INAUDIBLE) SO THAT'S WHAT CONFUSED ME.

ELIZABETH: YEAH. NO. NOT INVITING PEOPLE FROM AROUND THE STATE. NO.

CARLEY: OKAY.

MARSHA: OKAY. THAT'S OKAY.

THOSE WHO ARE LOCAL --

CARLEY: FOUR MINUTES LEFT.

MARSHA: -- COULD DO A LITTLE BIT OF THINKING ABOUT WHERE THE SUBCOMMITTEE MEMBERS MIGHT POSSIBLY BE ABLE TO STAY. MAYBE WE COULD TALK ABOUT THAT AT THE NEXT MEETING, AND I'M FEELING -- NOW THAT WE HAVE THE BIGGEST QUESTION SETTLED, I WOULD BE COMFORTABLE WAITING TWO WEEKS UNTIL OUR NEXT MEETING. DOES ANYBODY HAVE A DIFFERENT OPINION ON THAT?

RYAN: WHATEVER FOLKS THINK. SO LET'S SEE. TUESDAY WOULD BE AUGUST 1ST, YOU'RE TALKING ABOUT?

MARSHA: THAT SOUNDS ABOUT RIGHT.

RYAN: SOUNDS GREAT. SOUNDS WONDERFUL.

MARSHA: MAYBE AT THAT MEETING, TOO, WE CAN START TALKING ABOUT --

RYAN: ANYONE ELSE HAVE A THOUGHT ON THAT?

MARSHA: YEAH. I WAS JUST GOING TO SAY, MAYBE AT THAT MEETING WE CAN START TALKING ABOUT GETTING GOING ON THE PUBLICITY.

CARLEY: I'M OKAY WITH TWO WEEKS.

MARSHA: ALL RIGHT. THEN I WILL PLAN TO SEE ALL OF YOU IN TWO WEEKS.

DOES ANYBODY HAVE ANY FINAL THOUGHTS BEFORE WE CLOSE THIS OUT?

WELL, THANK YOU ALL FOR ALL OF YOUR WORK ON THIS. I REALIZE THAT, PARTICULARLY, OUR LOCAL PARTNERS HAVE PUT IN AN INCREDIBLE AMOUNT OF WORK ALREADY, AND I AM MORE GRATEFUL FOR THAT THAN I CAN TELL YOU. SO THANK YOU.

RYAN: AND THANK YOU. YES. THAT'S GREAT. EVERYONE HAVE A GREAT NIGHT.

MARSHA: YES. AND I WILL SEE YOU IN TWO WEEKS.
