Employment estimates in this report are generated by the U.S. Bureau of Labor Statistics (BLS). Monthly employment estimates are subject to revision in subsequent months when more sample data become available. BLS data in this report are rounded to the nearest 100.

On a seasonally adjusted basis, preliminary estimates from the federal Bureau of Labor Statistics (BLS) indicate nonfarm employment in Washington rose by 6,100 in April 2023.1 BLS estimates the private sector gained 7,200 jobs during the month and the public sector lost 1,100 jobs.

On a not seasonally adjusted basis, estimates for April 2022 through Apr 2023 indicate an increase in employment of 116,700 for the state. The private sector gained 98,300 jobs while the public sector gained an estimated 18,400 jobs over the year.

Washington's preliminary seasonally adjusted unemployment rate for April 2023 is 4.3 percent. The revised estimated March 2023 unemployment rate is at 4.5 percent. The April 2022 unemployment rate was 4.1 percent.

BLS estimates of monthly job gains and losses are based on a survey of businesses. Preliminary estimates are subject to revision. The March 2023 preliminary estimated gain of 1,500 jobs was revised to a gain of 4,300 jobs.

Resident civilian labor force and unemployment, seasonally adjusted

The resident civilian labor force is the total number of people in the workforce, employed and unemployed, ages 16 and up.

The number of unemployed is the estimated number of people who currently do not have a job, are available for work and have actively looked for work in the last four weeks.

The unemployment rate is the ratio of the estimated number of unemployed divided by the civilian labor force.

¹Most of the employment numbers discussed in this report refers to jobs, not people. For example, if a person holds two positions, these positions are counted as two jobs in the employment series. In the section titled "Unemployment," these positions refer to individuals, not jobs. In this case, a person holding two jobs is counted only once.

Unemployment, seasonally adjusted


The BLS estimates Washington's preliminary seasonally adjusted unemployment rate for April 2023 is 4.3 percent. The revised estimated March 2023 unemployment rate is 4.5 percent.

According to BLS estimates, the number of unemployed people fell by 5,700 in April 2023 compared to March 2023. At the same time, the number of employed people rose by an estimated 15,700. Overall, this amounted to an increase of 10,000 people in the labor force.

The preliminary April 2023 unemployment rate is 0.2 percentage points higher than the April 2022 rate of 4.1 percent.

Based on BLS estimates, Washington state nonfarm employment increased by 6,100 jobs from March 2023 to April 2023.







U-6 unemployment rate

The U.S. Bureau of Labor Statistics (BLS) recently updated its "alternative measures of labor underutilization" for states to include four-quarter rates through first quarter 2023. One such alternative measure is the U-6 rate, which considers not only the unemployed population in the official "U-3" unemployment rate, but also marginally attached workers and those employed part time for economic

reasons. The U-6 rate is defined by BLS as the "total unemployed, plus all marginally attached workers, plus total employed part time for economic reasons, as a percent of the civilian labor force plus all marginally attached workers." This U-6 measure measures the "unemployed, underemployed, and those who are not looking but who want a job."

The U-6 annual average unemployment rate for the four-quarter period through first quarter 2023 for Washington state was 7.4 percent. This was lower compared to the 10.1 percent average annual U-6 unemployment rate for 2021. The U.S. U-6 average annual unemployment rate for 2022 was 6.9 percent.

Industry employment in Washington, seasonally adjusted

One-month employment change by industry

Based on a BLS survey of businesses and governments, Washington gained an estimated 6,100 jobs during the month, on a seasonally adjusted basis:

- Overall, employment increased in seven major industries, decreased in five and was unchanged in one in April.
- Private sector employment is estimated to have increased by 7,200 and government employment decreased by 1,100.
- Construction employment rose by 4,300, with 3,700 jobs added by specialty trade contractors.
- The number of jobs in education and health services increased by 2,500 overall, with by 800 jobs gained in ambulatory health care services.
- Leisure and hospitality employment increased by 1,300 overall, with 2,200 jobs gained in food services and drinking places.
- Retail trade employment increased by 700 overall, with 1,100 jobs added by general merchandise stores.
- Professional and business services employment decreased by 800 overall, with 1,000 jobs lost in employment services.

Industry employment in Washington, not seasonally adjusted

Change by industry over the year

Based on a BLS survey of businesses and governments, Washington gained an estimated 116,700 jobs from April 2022 through April 2023.

- Overall, all thirteen major industries expanded.
- Private sector employment rose 3.4 percent, up an estimated 98,300 jobs.
- Public sector employment rose 3.2 percent, up an estimated 18,400 jobs.
- Education and health services employment rose 26,200 overall, with 22,400 jobs added in health services and social assistance.
- Employment in leisure and hospitality is up by 21,300, with food services and drinking places adding 15,200 jobs.
- Professional and business services employment increased by 16,100, with 4,900 jobs added in computer systems design and related services.
- Employment in construction is up 8,700 overall, led by an increase of 4,500 by specialty trade contractors.
- Manufacturing employment increased by 6,100, with 5,900 jobs gained in aerospace product and parts manufacturing.

Seasonally adjusted employment

Seasonally adjusted numbers account for normal seasonal patterns that occur year after year, such as strong seasonal hiring in retail trade around the holidays. Taking into account normal seasonal variations makes it possible to see unusual changes in employment levels.

Normal seasonal change is the expected monthly change in employment based on history.

Estimated change is the employment change over the month based on BLS survey data.

Seasonally adjusted change is change in employment accounting for normal seasonal patterns.

Based on historical patterns, Washington employment typically increases by 14,100 from March to April. This year the state gained an estimated 20,200 jobs, amounting to a seasonally adjusted increase of 6,100 jobs.

- Typically, manufacturing employment decreases by 1,400 in April. On a seasonally adjusted basis, manufacturing employment increased by 100 as the estimated decrease was 1,300.
- The normal seasonal gain in leisure and hospitality employment is 5,700 in April. The estimated gain was 7,000, so employment increased by 1,300 on a seasonally adjusted basis.
- The employment decrease on a seasonally adjusted basis was 800 in professional and business services in April. The normal seasonal increase is 3,800. It is estimated to have increased this April by 3,000.
- The estimated employment increase in construction was 6,300. The normal seasonal increase is 2,000, so on a seasonally adjusted basis, construction employment increased by 4,300.
- Employment in retail trade normally increases by 600. It is estimated to have increased by 1,300 this April so it increased by 700 on a seasonally adjusted basis.
