Summary

Meeting Recorded

This meeting was <u>recorded</u> and also livestreamed by TVW.

Welcome and Opening Remarks

After a technical problem occurred at the start of the meeting. The meeting was ended and restarted at 2:10pm. ESD Unemployment Insurance Customer Support Director, JR Richards, welcomed everyone and asked committee assistant Colin Helsley to call roll.

Meeting Minutes

JR Richards requested that everyone review the December 2023 UIAC meeting minutes and provide their feedback. Josh Swanson made a motion to approve the minutes and Bob Battles seconded the motion. All in favor said "aye". No members were opposed. The December 6, 2023 meeting minutes were approved.

Rulemaking Update

JR Richards handed the meeting over to Stephanie Frazee, Legislation and Rules Coordinator, ESD, to provide a rulemaking update. Stephanie presented information from the following slides.

Minutes

Rulemaking

- **Overpayment Waivers** Formally adopted permanent rules on December 1, 2023. Rules became effective January 1, 2024.
- **Conditional Benefit Definition** Formally adopted rules on December 7, 2023. Rules became effective January 7, 2024.

Rulemaking

- Wildfires and Other Disasters Filed emergency rules in response to wildfires in the state. Held a hearing on adopting the rules permanently on January 23, 2024. Working on formally adopting the permanent rules.
- Expanded Voluntary Quits (HB 1106) Officially proposed rules with definitions of "family member" consistent with PFML definitions and incorporating updates from the bill that are effective September 3, 2023. Held hearing on December 8, 2023. Working on formally adopting rules.
- Also working on drafting rules incorporating quitting due to inaccessible care for a child or vulnerable adult and defining a split shift.

Rulemaking

- Transportation Network Companies (HB 1570) Working on drafting rules concerning relief of benefit charges for part-time workers and potential other rules needed to implement bill.
- Cross-Program Payment Allocation Pre-proposal inquiry filed. Drafting rules to address how employer payments are allocated across UI, WA Cares, and PFML.
- Overpayments Correction Began expedited rulemaking to update an outdated cross-reference. Objection was submitted, and we are now working on officially proposing the rule change.

Agency request legislation

HB 1975 & SB 6028

Pandemic-era overpayment interest Both bills voted out of their policy committees unanimously

Waives interest accrued on pandemic-era overpayment interest (Feb 2020 – Sept 2021). Interest on these overpayments will not resume until Jan 1, 2025.

HB 1898

Benefit Charging Voted out of House (93 yeah, 0 no, 5 excused)

Cleans up the benefit charging statutes for clarity. Does not make substantive changes.

HB 1901

Voluntary Contributions

Voted out of LAWS unanimously

Removes the sunset to temporary changes to voluntary contributions program from 2021:

- Removed the 10% surcharge
- Reduced the amount of the contribution required to participate.

Legislation update

Agency request legislation: Pandemic-era overpayment interest

The bills impact claimants that are not successful in getting a waiver.

- Currently, 96% of waiver applications have been approved
- If the waiver is approved, the overpayment + accrued interest is waived

Bases on the current waiver approval rate, ESD anticipates:

- \$6M in interest being waived
- \$8.2M in paid interest will be refunded to individuals that have already paid interest

HB 1095 and 5109

Concerning unemployment insurance benefits for striking or lockout workers

HB 1095 (2023) – Reintroduced in Appropriations SB 5109 (2023) – Reintroduced in Ways and Means

HB 1893 and SB 5777

Concerning unemployment insurance benefits for striking or lockout workers

HB 1893 – Scheduled for executive session in LAWS earlier this morning SB 5777 – Passed out of Labor & Commerce on Jan 17

HB 2230

Economic Security for All (EcSA)

Scheduled for executive session in LAWS on Jan 30

Bob Battles asked, regarding HB 1893 and SB 5777, if any issues with able and available requirements could be foreseen. Caitlyn and Stephanie Frazee answered that under these bills the striking worker



would still be considered attached to the employer they were striking, so they wouldn't be required to work search and would be allowed to return to work for that employer when the strike ends. Bob asked whether there were concerns of conformity issues with this. Stephanie answered that there were none identified, but that striking workers would still be required to be available, as with other claimants.

Navigator Grant

JR handed the floor to Stephanie Sams, UICS Policy and Legislative Implementation Manager, ESD, and Rafael Colon, Navigator Program Manager, ESD to provide an update on the Navigator Program.

Stephanie presented information from the following slides.

- 21 bidders across the state requesting over \$7.9 million
- Selected nine CBO successful bidders
 - Total grant \$2,051,623
 - Period of performance is 18 months from Jan. 2, <u>2024</u> to June 14, 2025


