**Purpose:** This rulemaking will update WAC 192-150-055 to reflect portions of Engrossed Substitute House Bill 1106 (2023), which, among other things, expanded good cause for voluntarily quitting a job due to death, illness, or disability and expands "immediate family member" to "family member." Therefore, this rulemaking will change "immediate family" to "family member" effective September 3, 2023, defines "family member," updates various definitions of family members, and will require that, to establish good cause for leaving work voluntarily because of illness or disability or the illness, disability, or death of a family member, a claimant must make reasonable efforts to preserve their employment status by requesting changes in working conditions, changes to work schedule, or a leave of absence.
