Purpose of the proposal and its anticipated effects, including any changes in existing rules: The proposal clarifies that an individual on a leave of absence is eligible for unemployment benefits as long as the individual (1) meets the definition of								
"unemployed" per RCW 50.04.310; and (2) meets all other eligibility requirements provided in RCW 50.20.010.								
<b>Reasons supporting proposal:</b> In May of 2022, the Department received a petition requesting that the Department amend								
WAC 192-170-080 to eliminate WAC 192-170-080(1)(a), which states, "If you are on a leave of absence, you are not unemployed and thus not eligible for benefits."								
WAC 192-170-080(1)(a), which states that someone on a leave of absence is not "unemployed," was determined to be								
"invalid" by the Commissioner of the Employment Security Department in 2011 under <i>In re Ausburn</i> , Empl. Sec. Comm'r Dec.2d 971 (2011). In 2021, the U.S. Department of Labor issued guidance stating an individual should be considered								
"unemployed" when the individual incurs a reduction in work hours and their wages are less than their weekly benefit amount.								
				Rulemaking is therefore necessary to revisit whether				
ndividuals on a leave of absence should or should not be considered "unemployed."
